Mayor Weaver called the meeting to order promptly at 6 p.m. He requested Councilmember John Foust give the invocation. Councilmember Allison Brown led in the recital of the Pledge of Allegiance.

Mayor Weaver asked that the agenda be reviewed and approved by Council. Councilmember Jim Looney made a motion to approve the agenda as presented and Councilmember Anne Morrow seconded the motion. Motion carried by unanimous vote.

City Clerk Lisa Hoyle read the minutes of the November 4, 2013 regular meeting. Councilmember Anne Morrow made a motion to adopt the minutes as read, and Councilmember Tony Fountain seconded the motion. Motion carried by unanimous vote.

Item A under Old Business, Mayor Weaver recognized Michael Castagna, Director of Planning and Zoning, to present to Council the remaining 2014 alcohol license renewal applications. See list attached hereto. Councilmember Anne Morrow made a motion to approve the license renewal requests and Councilmember Allison Brown seconded the motion. Motion carried by unanimous vote.

Item B under Old Business, Mr. Castagna presented an alcohol license application to Council for approval. He informed Council that the new owners of Jasper Beverage had completed the application process and are now requesting that their application for a beer/wine/distilled spirits by package license be approved. Councilmember Jim Looney made a motion to approve the license to sell beer, wine and distilled spirits by package and Councilmember Anne Morrow seconded the motion. Motion carried by unanimous vote.

Item C under Old Business, Mr. Castagna presented an alcohol license application to Council for approval. He informed Council that the new owners of JD's Country Cooking and Tavern had completed the application process and are requesting their application for beer and wine by the drink license be approved. Councilmember Jim Looney made a motion to approve the license to sell beer and wine by the drink and Councilmember Anne Morrow seconded the motion. Motion carried by unanimous vote.

Item D under Old Business, Mr. Castagna presented to Council the second reading of the new Sec. 10-325 Brown Bagging/Open Container Alcohol Ordinance. Mr. Castagna read the ordinance. Jim Looney made a motion to adopt the ordinance and Councilmember Tony Fountain seconded the motion. Discussion followed with Mr. Castagna and Bill Pickett, City Attorney. Motion carried by unanimous vote.

Item E under Old Business, Mr. Castagna presented the second reading of the new Sec 318 - 324 Alcohol Catering License Ordinance. Mr. Castagna read the ordinance.
