The qualifying period will be Monday, August 21, 2023, through Friday, August 25, 2023. The place of qualifying will be at the administrative office of the Pickens County Board of Elections located at 3100 Camp Road, Suite B, Jasper Georgia. The qualifying fee for the seat of the Mayor shall be \$180.00 and \$90 for each Council seat. The last day for voter registration will be Tuesday, October 10th, due to Monday being Columbus Day.
