Mayor Weaver asked that the agenda be reviewed and approved by Council with an addition of one item under New Business, Presentation of Insurance by Joe Walker. Councilmember Tony Fountain made a motion to approve the agenda as amended and Councilmember Anne Morrow seconded the motion. Motion carried by unanimous vote.

City Clerk Tacie Williams read the minutes of the November 13, 2012 regular meeting. Councilmember Anne Morrow made a motion to adopt the minutes as read, and Councilmember Allison Brown seconded the motion. Motion carried by unanimous vote.

Item A under New Business, Mayor Weaver recognized Joe Walker of WS Pharr to present the liability and workers compensation insurance policies for 2013. After discussion, Councilmember John Foust made a motion to accept the proposal to enter into a contract with Trident for liability insurance with an annual premium totaling \$86,232 and enter into another contract with Key Risk for workers compensation insurance with an annual premium totaling \$92,366 for the calendar year 2013. Councilmember Anne Morrow seconded the motion. Motion carried by unanimous vote.

Item B under New Business, Finance Director Tacie Williams presented the 2013 Operating Budget for Council's review. No action necessary.

Item C under New Business, Tacie Williams presented the 2012 tax millage rate as advertised and as considered in the upcoming budget. She recommended Council adopt a millage rate of 4.69 mils. Councilmember Jim Looney made such motion, and Councilmember John Foust seconded the motion. Motion carried by unanimous vote.

Item D under New Business, Tacie Williams presented to Council a lease option for the purchase of a Chevrolet Tahoe. This purchase was included in the 2012 budget; however, approval is necessary to enter into a lease for the purchase.

Ms. Williams recommended entering into a contract with BB&T Governmental Finance through Georgia Municipal Association for three years at a 3.24% interest with a monthly payment of \$1,386.91. Councilmember Jim Looney made a motion to accept Ms. Williams'
