| #1 Consideration and approval to advertise for Millage Rate | |

DISCUSSION:

Mayor Lawrence called on Finance Director Lindsey Williams. Mrs. Williams stated that she is waiting on information from the county before she can give the exact tax digest numbers. Mrs. Williams explained that the city will receive the tax digest and inflationary growth chart, allowing us to fill out the correct forms to help determine if the city should roll back its millage rate. Mrs. Williams is requesting approval to advertise once she has the information from the county. If the council does not want to rollback the millage rate, we are required by CGA 48-5-32.1 to hold three public hearings notifying the public of a tax increase. Mrs. Williams stated by law we have to advertise a week in advance before each public hearing. Mrs. Williams noted to the public that the taxes will not necessarily increase, but if your assessment went up then your taxes may go up. Councilmember Proctor stated that we receive the information from the tax assessor's office for every parcel of land that is in the city, providing us with the total value of our properties in the city. Then we compare that to what last years are and that is what gives us the index that we use to determine what should be our final rate of tax.
